The Commission approved the minutes of the April 29, 2010 Personnel Commission meeting.

In accordance with the Personnel Commission Rules, staff submitted classification recommendations consisting of a Request for Reclassification from Harold McCarty, Assistant Grounds Manager for the consideration of the Commission. Susan Leaming, Personnel Analyst, provided an overview of the classification items listed. The Chairperson Ulaszewski asked if anyone in the audience had questions or comments regarding the classification items. Dan Ewaskey, Unit B Vice President commented that CSEA wanted to go on record saying that they didn’t believe this was the time to reclassify a management position when other employees were being laid-off. Chairperson Ulaszewski stated that while the Commission is sensitive to the timing of the study, ultimately the reclassification of this individual resulted in the reduction of three management/supervisory full-time positions as was outlined in the staff report.
