REPORT FROM THE EXECUTIVE OFFICER

Ramon Curiel, Executive Officer, reported to the Commissioners that the lay-off process continues with the district sending out notices to certificated employees. The next two board agendas will affect classified employees, particularly categorically funded classified employees, due to budget short falls. The next Board of Education meeting is March 25 which will combine a workshop in the morning and a regular meeting in the evening.

Mr. Curiel announced that the Employee of the Year Selection Committee met. He stated that the nomination form was sent to each employee with the help of the Public Information Office, and to School Secretaries to post at their sites. Nominations have already been received.

Mr. Curiel reported that the State of California recognizes Classified Employees the week of May 17-21, and the District Classified Event will be May 21, from 1-4 at the TRC location.

Mr. Curiel asked the Personnel Commission Division Heads to give a brief update of the Department's activities. The staff managers present gave individual reports to the Commission on the current projects of their units.

Mr. Curiel relayed that there is no new information about furlough days but guidelines are being developed. He reported that it is the intent of the guidelines to consider an employee's retirement service credit so that employees may continue to accrue the same service credit as they did before taking furlough days.
